GREETING:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the Inhabitants of the several precincts of the Town of Templeton, County of Worcester, qualified to vote in elections and town affairs to meet in the Narragansett Regional High School, South Main Street, Baldwinville, on June 24, 1992 at 7:30 P.M., then and there to act on the following articles:

Annual Town Meeting was adjourned at 7:30 P.M. to hold Special Town Meeting.

Article 1. To see if the Town will vote to Raise and Appropriate from the fiscal year 1993 tax levy or transfer from Available Funds a sum of money for the purchase and installation of an auxiliary engine to run the Otter River Water Pump Station during an emergency; or to take any other action relative thereto.

No motion

Article 2. To see if the Town will vote to Raise and Appropriate from the fiscal year 1993 tax levy or transfer from Available Funds a sum of money to pay for the Field Driver and related expenses through June 30, 1993; or to take any other action relative thereto.

On a motion duly made and Seconded the Town Voted to transfer from the General Insurance Account the sum of Five Hundred Dollars (\$500.00) to pay for the Field Driver and related expenses through June 30, 1993.
