To either of the Constables of the Town of Templeton in said County.

GREETINGS:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the Inhabitants of the Precincts of the Town of Templeton, County of Worcester, qualified to vote in elections and town affairs to meet at the Narragansett Regional High School, 464 Baldwinville Road, Baldwinville, MA, on Wednesday, December 4, 1996 at 7:00 p.m. then and there to act on the following articles:

Article 1 To see if the Town will vote to approve a sum of money authorized by vote of the Montachusett Regional Vocational Technical School District School Committee on November 6, 1996 for reconstructing to equipping, remodeling or making extraordinary repairs to the District School facilities; or to take any other action relative thereto.

On a motion duly made and seconded the Town voted to approve Seventeen Thousand Four Hundred Forty-Five Dollars (\$17,445.00) for three years starting in the Year 2000, and Fourteen Thousand, Ninety-Six Dollars (\$14,096.00) for twenty years starting in the Year 2003 for a total of Three Hundred Thirty-Four Thousand, Two Hundred Fifty-Five Dollars (\$334,255.00), to authorize by vote of the Montachusett Regional Vocational Technical School District School Committee on November 6, 1996, for reconstructing to, equipping, remodeling, or making extraordinary repairs to the district school facilities.

Article 2 To see if the Town will vote to Raise and Appropriate or Transfer from Available Funds a sum of money to lease two (2) Fully Equipped One Ton Four Wheel Drive Trucks; or to take any other action relative thereto.

On a motion duly made and seconded the Town voted to Transfer Four Thousand Dollars (\$4,000.00) from the Insurance Recoveries-Highway Department Accident (Vehicle) Account to the Highway Department Expense Account, to lease two (2) Fully Equipped One Ton Four Wheel Drive Trucks.

Article 3 To see if the Town will vote to Transfer from the Fire Department Insurance Recoveries Receipts Reserve for Appropriation Account to the Fire Department Expense Account; or to take any other action relative thereto.

On a motion duly made and seconded the Town voted to Authorize to Transfer Two Thousand Seven Hundred Eight Dollars (\$2,708.00) from the Fire Department Insurance Recoveries Receipts Reserve for Appropriation Account to the Fire Department Expense Account.

And you are hereby directed to serve this warrant by posting attested copies thereof in each Precinct; namely at the Post Office in Templeton, the Post Office in East Templeton, the Post Office in Baldwinville and at Cote's Market in Otter River, fourteen (14) days at least before the time of holding said meeting and by causing notice of the same to be published once in the Gardner News, a newspaper in said County in the City of Gardner.

Hereof, fail not, and make due return of this warrant with your doings thereon to the Town Clerk at the time and place of said meeting.
