GREETINGS:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the Inhabitants of the precincts of the Town of Templeton, County of Worcester, qualified to vote in elections and town affairs to meet at the Narragansett Regional High School, 464 Baldwinville Road, Baldwinville, MA, on Wednesday, October 23, 1996 at 7:00 p.m. then and there to act on the following articles:

Article 1 To see if the Town will vote to Transfer a sum of money from the Selectmens Salaries Account to the Selectmen's Office Salaries Account; or to take any other action relative thereto.

On a motion duly made and seconded the Town voted to authorize to transfer the sum of Six Hundred Dollars (\$600.00) from the Selectmen's Salaries Account to the Selectmen's Office Salaries Account.

Passed

Article 2 To see if the Town will vote to Transfer a sum of money from the Selectmen Salaries Account to the Assistant Town Accountants Office Salaries Account; or to take any other action relative thereto.

On a motion duly made and seconded the Town voted to authorize to transfer the sum of One Thousand, Three Hundred Sixty Two Dollars and Eighty Cents (\$1,362.80) from the Selectmen Salaries Account to the Assistant Town Accountant Office Salaries Account.

Article 3 To see if the Town will vote to Transfer from the Selectmen Salaries Account to the Town Building Expense Account; or to take any other action relative thereto.

On a motion duly made and seconded the Town voted to authorize to transfer the sum of One Thousand, Seven Hundred Thirty-four Dollars and

Forty Cents (\$1,734.40) from the Selectmen Salaries Account to the Town Building Expense Account.

Article 4 To see if the Town will vote to amend the action taken under Article 46 of the Warrant for the 1996 Annual Town Meeting relative to the Sewer Enterprise Funds so to increase the total appropriation by \$1,400,000 such additional monies to be raised from sewer receipts and to be used to defray the expenses of the Sewer Enterprise Fund and for Sewer Department, or to take any other action relative thereto.

On a substitute motion the Town voted to amend the action taken under Article #46 of the Warrant for the 1996 Annual Town Meeting relative to the Sewer Enterprise Funds so to increase the total appropriation by \$1,400,000.00 . Such additional monies to be raised from tipping fees from outside sewer haulers to the Town of Templeton Publicly Owned Treatment Works, (P.O.T.W.). The additional monies raised to be used by the Sewer Commissioners for the operating costs of the Town of Templeton Publicly Owned Treatment Works, (P.O.T.W.), legal expenses, engineering expense and other expenses associated with Templeton P.O.T.W.

Article 5 To see if the Town will vote to transfer from Fiscal Year 1997 Recreation Commission Expense, a sum of money to pay a Fiscal Year 1996 Recreation Commission bill; or to take any other action relative thereto.

On a motion duly made and seconded the Town voted to Authorize to Transfer from Fiscal Year 1997 Recreation Commission Expense, a sum of Two Hundred Twenty-Four Dollars (\$224.00) to pay a Fiscal Year 1996 Recreation Commission bill.

Article 6 To see if the Town will vote to approve a sum of money authorized by vote of the Montachusett Regional Vocational Technical School District School Committee on September 4, 1996, for reconstructing to, equipping, remodeling or making extraordinary repairs to the District School facilities; or to take any other action relative thereto.
