To either of the Constables of the Town of Templeton in said County.

GREETINGS:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the Inhabitants of the precincts of the Town of Templeton, County of Worcester, qualified to vote in elections and town affairs to meet at the Baldwinville Elementary School, 16 School Street, Baldwinville, MA, on Tuesday, June 23, 1998 at 8:00 p.m. then and there to act on the following articles:

Article 1        To see if the Town will authorize the Board of Selectmen to utilize a sum of money appropriated at the February 24, 1998 Special Town Meeting for installing a heating system in the Town Office Building in Otter River, to install a heating, ventilation, and air conditioning (HVAC) system in the aforementioned building; or to take any other action relative thereto.

On a motion duly made and seconded the Town voted to authorize the Board of Selectmen to utilize Twenty-Seven Thousand Dollars (\$27,000.00) which was appropriated at the February 24, 1998 Special Town Meeting for installing a heating system in the Town Office Building in Otter River, to install a heating, ventilation, and air conditioning (HVAC) system in the aforementioned building.

**Passed**

Article 2        To see if the Town will vote to Transfer a sum of money from the General Insurance Account to the Town Building Expense Account; or to take any other action relative thereto.

On a motion duly made and seconded the Town voted to Transfer Three Hundred Fifty Dollars (\$350.00) from the General Insurance Account to the Town Building Expense Account.

Article 3        To see if the Town will vote to Transfer a sum of money from the General Insurance Account to the Town Building Expense Account to 1) purchase one or more personal computers capable of supporting a local area network (LAN), 2) to upgrade the existing personal computers, and 3) to install a local area network in the Otter River Town Office Building to facilitate communication and data transfer within the building and

remotely via dial in with all external town departments; or to take any other action relative thereto.

On a motion duly made and seconded the Town voted to Transfer Five Thousand Six Hundred Dollars (\$5,600.00) from the General Insurance Account to the Town Building Expense Account to 1) purchase one or more personal computers capable of supporting a local area network (LAN), 2) to upgrade the existing personal computers, and 3) to install a local area network in the Otter River Town Office Building to facilitate communication and data transfer within the building and remotely via dial in with all external town departments.

**Passed**

Article 4 To see if the Town will vote to Transfer from the General Insurance Account a sum of money to the Trade School Expense Account; or to take any other action relative thereto.

On a motion duly made and seconded the Town voted to Transfer Four Thousand One Hundred Twenty-Six Dollars (\$4,126.00) from the General Insurance Account to the Trade School Expense Account.

**Passed**

Article 5 To see if the Town will vote to Transfer a sum of money from the Interest on Long Term Debt Phase IVB to the Interest on Long Term Sanitary Landfill Account; or to take any other action relative thereto.

On a motion duly made and seconded the Town voted to Transfer Two Thousand Seven Hundred Ten Dollars (\$2,710.00) from the Interest on Long Term Debt Phase IVB to the Interest on Long Term Sanitary Landfill Account.

Article 7 To see if the Town will vote to Transfer a sum of money from the General Insurance Account to the Group Insurance Account; or to take any other action relative thereto.

On a motion duly made and seconded the Town voted to Transfer Twenty-Seven Thousand dollars (\$27,000.00) from the General Insurance Account to the Group Insurance Account.

Article 9 To see if the Town will vote to Transfer a sum of money from the Police Wage Account to the Advisory Board Special Reserve Account; or to take any other action relative thereto.

On a motion duly made and seconded the Town voted to Transfer a sum of Seven Thousand Nine Hundred Dollars (\$7,900.00) from the Police Wage Account to the Advisory Board Special Reserve Account.

**Passed**

Article 10 To see if the Town will vote to Transfer a sum of money out of the Fire Department Salaries Account to the Fire Department Expense Account; or to take any other action relative thereto.

On a motion duly made and seconded the Town voted to Transfer Twelve Thousand Dollars (\$12,000.00) out of the Fire Department Salaries Account to the Fire Department Expense Account.

Article 12 To see if the Town will vote to Transfer a sum of money from the General Insurance Account to the Assessors Mapping Account for updating the Assessor's Maps; or to take any other action relative thereto.

On a motion duly made and seconded the Town voted to Transfer Two Thousand Dollars (\$2,000.00) from the General Insurance Account to the Assessors Mapping Account for updating the Assessor's Maps.

Article 13 To see if the Town duly recommend the approval of the definitive subdivision plan for Red Fox Crossing, off Old Winchendon Road in Otter River, MA submitted by William W. Harris dated May 17, 1988; or to take any other action relative thereto.

On a motion duly made and seconded the Town voted to accept Red Foxx Crossing as a Public Way, in accordance with the layout approved by the Board of Selectmen, the road being shown on a plan on file with the Town Clerk's office, and to authorize the Board of Selectmen to acquire any necessary easements or fee simple interests through gift, eminent domain, purchase or otherwise.

And you are hereby directed to serve this warrant by posting attested copies Thereof in each Precinct; namely at the Post Office in Templeton, the Post Office in East

Templeton, the Post Office in Baldwinville, and at Cote's Market in Otter River, fourteen (14) days at least before the time of holding said meeting and by causing notice of the same to be published once in the Gardner News, a newspaper in said County in the City of Gardner.
