In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the Inhabitants of the precincts of the Town of Templeton, County of Worcester, qualified to vote in elections and town affairs to meet at the Narragansett Regional High School, 464 Baldwinville Road, Baldwinville, MA, on Tuesday, May 12, 1998 at 8:00 p.m. then and there to act on the following articles:

Article 1 To see if the Town will vote to Transfer a sum of money from the General Insurance Account to the Town Travel Expense Account; or to take any Other action relative thereto.

On a motion duly made and seconded the Town voted to Transfer a sum of Four Hundred Fifty Dollars (\$450.00) from the General Insurance Account to the Town Travel Expense Account.

Article 2 To see if the Town will vote to Transfer a sum of money from the General Insurance Account to the Town Building Expense Account; or to take any Other action relative thereto.

On a motion duly made and seconded the Town voted to Transfer a sum of Four Thousand, Three Hundred Thirty-Seven Dollars and Two Cents (\$4,337.02) from the General Insurance Account to the Town Building Expense Account.
