To either of the Constables of the Town of Templeton in said County.

GREETINGS:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the Inhabitants of the precincts of the Town of Templeton, County of Worcester, qualified to vote in elections and town affairs to meet at Narragansett Regional High School, 464 Baldwinville Road, Baldwinville, MA on Monday, December 6, 1999, at 7:00 PM, then and there to act on the following articles:

- Article 1: To see if the Town will vote to affirm the debt authorization vote of the Narragansett Regional School Committee, taken on October 13, 1999, as follows:
- A. Voted: That for the purpose of financing costs of reconstructing, adding to, equipping, remodeling or making extraordinary repairs to the Narragansett High School in connection with increasing the capacity of the facility, including costs incidental and relating thereto, there be and hereby is authorized the incurring of debt on the full faith and credit of the District under and pursuant to Chap. 71, Section 16 (d) of the General Laws, as amended and supplemented, by the issuance and sale at one time or from time to time of bonds or notes in the aggregate principal amount of \$511,724.00, in addition to the \$152,680.00 appropriated from available funds and all additional sums authorized for this project.
  - B. Voted: That the sum of \$152,680.00 is appropriated from nonrecurring interest income for the purpose of paying the estimated District share of the aforesaid additional costs of the High School construction project.

On a motion duly made and seconded the Town voted to affirm the debt authorization vote of the Narragansett Regional School Committee, taken on October 13, 1999, as follows:

- A. Voted: That for the purpose of financing costs of reconstructing, adding to, equipping, remodeling or making extraordinary repairs to the Narragansett High School in connection with increasing the capacity of the facility, including costs incidental and relating thereto, there be and hereby is authorized the incurring of debt on the full faith and credit of the District under and pursuant to Chap. 71, Section 16 (d) of the General Laws, as amended and supplemented, by the issuance and sale at one time or from time to time of bonds or notes in the aggregate principal amount of \$511,724.00, in addition to the \$152,680.00 appropriated from available funds and all additional sums authorized for this project.
