

COMMONWEALTH OF MASSACHUSETTS

WARRANT FOR SPECIAL TOWN MEETING  
December 18, 2003

To either of the Constables of the Town of Templeton in said County.

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the Inhabitants of the several precincts of the Town of Templeton, County of Worcester, qualified to vote in elections and Town affairs to meet in the Narragansett Regional Middle School in said Templeton on Thursday, December 18, 2003 at 7:00 o'clock P.M. then and there to act on the following articles:

- Article 1. To see if the Town will vote to accept and appropriate One Hundred Fifty Thousand Dollars (**\$150,000**) of donated funds from the Massachusetts Reserve Trust Fund; for the following purposes:
- Animal Control, Five Thousand Dollars (**\$5,000**).
  - Board of Assessors, Seven Thousand Five Hundred Ninety Dollars (**\$7,590**); Three Hundred Dollars (**\$300**) of which funds to go into the Board of Assessors Expense Account and Seven Thousand Two Hundred Ninety Dollars (**\$7,290**) into the Board of Assessors Office Salary Account.
  - Boynton Library, Twenty Six Thousand, One Hundred Thirty Five Dollars (**\$26,135**).
  - Building Department, Fourteen Thousand Eight Hundred Dollars (**\$14,800**).
  - Communications Commission, Ten Thousand Dollars (**\$10,000**).
  - Highway Department, Twenty Five Thousand, Seven Hundred Dollars (**\$25,700**); of which Twenty Thousand Seven Hundred Dollars (**\$20,700**) be put into the total Highway Department; and Five Thousand Dollars (**\$5,000**) into the Total Town Vehicle Machinery Maintenance Department.
  - Police Department, Twenty Thousand Four Hundred Eighty Seven Dollars (**\$20,487**).
  - Solid Waste Removal, Five Hundred Dollars (**\$500**).
  - Town Buildings Expenses, Seven Thousand Dollars (**\$7,000**).
  - Town Clerk Office Expense, Three Hundred Dollars (**\$300**).
  - Town Counsel Expenses, Six Thousand Seven Hundred Dollars (**\$6,700**).
  - Town Telephone Expense, Eight Thousand Dollars (**\$8,000**).
  - Town Treasurer's Account, Twelve Thousand, Seven Hundred Eighty Eight Dollars (**\$12,788**).
  - Advisory Board Reserve Fund, Five Thousand Dollars (**\$5,000**).

**An amended motion was made to transfer (\$2,800) to the Town Clerks Expense account, to pay for a possible Recall Election and reduce the Advisory Board Reserve Fund to (\$2,500).**

**Defeated**

On a motion duly made and seconded the Town voted to accept and appropriate One Hundred Fifty Thousand Dollars **(\$150,000)** of donated funds from the Massachusetts Municipal Wholesale Electric Co. (MMWEC) Working Capital Fund, for the following purposes:

- Animal Control, Five Thousand Dollars **(\$5,000)**.
- Board of Assessors, Seven Thousand Five Hundred Ninety Dollars **(\$7,590);**  
Three Hundred Dollars **(\$300)** of which funds to go into the Board of Assessors Expense Account and Seven Thousand Two Hundred Ninety Dollars **(\$7,290)** into the Board of Assessors Office Salary Account.
- Boynton Library, Twenty Six Thousand, One Hundred Thirty Five Dollars **(\$26,135)**.
- Building Department, Fourteen Thousand Eight Hundred Dollars **(\$14,800)**.
- Communications Commission, Ten Thousand Dollars **(\$10,000)**.
- Highway Department, Twenty Five Thousand, Seven Hundred Dollars **(\$25,700);** of which Twenty Thousand Seven Hundred Dollars **(\$20,700)** be put into the total Highway Department; and Five Thousand Dollars **(\$5,000)** into the Total Town Vehicle Machinery Maintenance Department.

- Town Clerk Office Expense, Three Hundred Dollars **(\$300)**.
- Town Counsel Expenses, Six Thousand Seven Hundred Dollars **(\$6,700)**.
- Town Telephone Expense, Eight Thousand Dollars **(\$8,000)**.
- Town Treasurer's Account, Twelve Thousand, Seven Hundred Eighty Eight Dollars **(\$12,788)**.  
Advisory Board Reserve Fund, Five Thousand Dollars **(\$5,000)**.
