To either of the Constables of the Town of Templeton in said County:

GREETINGS:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the Inhabitants of the several precincts of the Town of Templeton, County of Worcester, qualified to vote in elections and town affairs to meet at the Narragansett Regional Middle School in said Templeton on Tuesday, June 15, 2004, at 7:00 o'clock p.m. then and there to act on the following articles:

Article 1. To see if the Town will vote to raise and appropriate, transfer from available funds, or otherwise provide a sum of money from the Narragansett Regional School District for the fiscal year 2005, or to take any other vote or votes in relation thereto.

On a motion duly made and seconded the Town voted to raise and appropriate the sum of Two Million, Five Hundred Forty-Two Thousand, Nine Hundred Seven Dollars (**\$2,542,907.00**) for the Narragansett Regional School District for the fiscal year 2005.
